If access is denied to the Event by **OPTA**VIA for any reason, **OPTA**VIA will refund the unused amount of the registration price paid by the Event Attendee(s). Please be advised that certain content at the Event is accessible only to independent **OPTA**VIA Coaches and **OPTA**VIA reserves the right to restrict access to this content.

All proceedings shall be conducted in the city of **OPTA**VIA's corporate headquarters. Except as prohibited by law, the parties waive all rights and claims to punitive, incidental or consequential damages, including attorney's fees; and Event Attendees further waive all rights to have damages multiplied or increased.
