

# OPTAVIA® 2022 SPRING TAG TO WIN GIVEAWAY

## OFFICIAL TERMS & CONDITIONS

NO PURCHASE OR PAYMENT OF ANY KIND IS NECESSARY TO ENTER OR WIN THIS GIVEAWAY. VOID WHERE PROHIBITED OR RESTRICTED BY APPLICABLE FEDERAL, STATE, OR LOCAL LAWS AND REGULATIONS. OPEN ONLY TO RESIDENTS OF THE UNITED STATES, THE DISTRICT OF COLUMBIA, AND OTHER LOCALES UNDER THE UNITED STATES JURISDICTION, INCLUDING PUERTO RICO, GUAM, U.S. VIRGIN ISLANDS AND OTHER PROTECTED U.S. TERRITORIES. MUST BE 18 YEARS OF AGE OR OLDER. INTERNET ACCESS AND EMAIL ACCESS IS REQUIRED.

1. **BINDING AGREEMENT:** By participating in the **OPTAVIA** 2022 Spring Tag to Win Giveaway (the "Giveaway"), the independent **OPTAVIA** Coach (the "Entrant") fully and unconditionally agrees to accept these Official Terms & Conditions ("Terms & Conditions") and the decisions of the Sponsor, **OPTAVIA**, LLC, which are final and binding in all matters related to the Giveaway. To be eligible for a prize, the Entrant must fulfill all requirements set forth herein.
2. **ELIGIBILITY:** The Giveaway is open to U.S. residents who are at least 18 years of age or older and are also independent **OPTAVIA** Coaches during the Giveaway Entry Period ("Entry Period"). An independent **OPTAVIA** Coach is defined as an individual who has purchased an **OPTAVIA** Coach Business Kit (the "Business Kit") in good standing and without disciplinary action, i.e., in compliance with the **OPTAVIA** Policies, Procedures, Independent **OPTAVIA** Coach Agreement, and the Integrated Compensation Plan (collectively, "the Agreement"). **OPTAVIA**, its respective promotions agencies, any of its respective parent companies, affiliates, subsidiaries, officers, directors, partners, principals, partnerships, employees or agents (collectively, "the Giveaway Entities") and their immediate families (defined as spouse, mother, father, sisters, brothers, sons and daughters, regardless of where they reside) and members of their households (whether related or not) are ineligible to participate in this Giveaway.
3. **GIVEAWAY ENTRY PERIOD:** The Giveaway Entry Period commences at 4:00 p.m. EST on May 12, 2022 and closes at 12:00 p.m. EST on May 15, 2022.
4. **HOW TO ENTER:**
  - a. An Entrant shall enter the Giveaway by following "**@OPTAVIA**" on Instagram and tagging a minimum of two (2) friends in the comments section of the May 12, 2022 post on **OPTAVIA**'s official Instagram account that announces this Giveaway.
  - b. Only one entry will be considered per Entrant, regardless of the number of individuals tagged.
  - c. **Alternative Method of Entry:** An Entrant may also enter the Giveaway by submitting an entry via a postcard or a card that is no smaller than 3 ½ x 5 inches and no larger than 4 ¼ x 6 inches, with the name, **OPTAVIA** Coach ID Number, mailing address, and phone number with "**OPTAVIA** 2022 Spring Tag to Win Giveaway" written on the entry.     - i. All "write-in" entries must be received no later than May 15, 2022. There is a limit of one (1) write-in entry per Entrant. Each postcard is considered one (1) entry into the Giveaway. Multiple entries submitted or completed by anyone other than the Entrant are void. No mechanical reproductions will be accepted. Write-in entries must contain all items outlined above; otherwise, they are void and will not be eligible to win.
5. **ADDITIONAL ENTRY CONDITIONS:**
  - a. Instructions on how to enter and the prize(s) form part of these Terms & Conditions. There is no entry fee to participate in the Giveaway. Only one entry per Entrant may be submitted, multiple entries submitted or completed by anyone other than the Entrant are void.

The Prize Winner will be able to select either prize and size preference.
- b.
